- 18/0026**      **Apologies for absence** – Cllr Y Greenfield and H Metcalf
- 18/0027**      **Council members’ declaration of interests for items on the agenda** - None
- 18/0028**      **Minutes from previous meeting** - held on June 7<sup>th</sup> 2018 noted spelling of Maureen Major to be corrected. Wording of item 18/0024 to read “with a view *to setting a meeting to seek* funding”. Subject to these changes agreed as a true record and signed by the Chair.
- 18/0029**      **Update on actions taken by committee members**  
J Major has contacted NCC Property Services. Contact details given to J Sherrin to arrange meeting. L King reported on productive meeting with Inspire, notes previously circulated. Library running costs have been provided. Noted Parish Council would not become involved in running of any services, the discussion is about facility provision only. Discussion regarding the cost benefit of flexible spaces. Advised that only once the purpose of any new building is clear, should the need for flexible spaces be considered as they are an expensive option and not always necessary. L King presented an outline summary of exiting facilities in the village. Importance of ensuring any new development COMPLIMENTS these was agreed. L King also presented a list of stake-holders in the project. Agreed that a “stake-holder mapping” process should take place, linking all interested parties and ensuring consultation. S Wright noted that parking in the village remains an issue and should be considered in any plans. Ponyton in Manchester was recommended as a good example of village re-development to look at. St Anne’s and Bulwell also given as examples of joint services facilities.
