Section 2 - Planning Policy

The value of the Neighbourhood Plan has been brought to question following its adoption this year. The Parish Council considers it was been misled regarding the level of influence the Neighbourhood Plan holds in planning decision making. With no statutory obligation to take on board comments made by the Parish Council, it remains as much a consultee as it did prior to the making of the Neighbourhood Plan, with concerns raised being no more than "considered", as previously.

In relation to its links with the Local Plan, the Burton Joyce Neighbourhood Plan identified a need for smaller, more affordable housing. This is not being reflected in planning approvals. Applications are deliberately staying below the 15 houses trigger to avoid such housing stock becoming available. It is considered by the Parish Council that this loophole should be addressed in order to provide the housing that is *needed* in the village.

Greater clarity is needed for residents and representative groups regarding the process for making a representation at a GBC council meeting, particularly in relation to having the opportunity to speak.

Requested that Parish Councils be notified of objections to planning applications raised by neighbours, as it practiced at Newark & Sherwood District Council.

Request that notifications are sent to the Parish Council when decision notices are issued, with access to any stated conditions.
