- (ii) Correspondence from Rev. Anna Alls regarding voluntary group received and noted. Voluntary group have met with D List and Cllrs Hyde and Orders. Will produce a proposal to include detail of ideas discussed at the meeting. D List to present to next Amenities meeting an overall proposal for work to the front borders of the cemetery, with pockets of planting volunteers could work on, sympathetic to the cemetery environment.
- (iii) Other maintenance issues – The lychgate is starting to rot – will require a specialist contractor to repair.

AM20/185 **Roberts Recreation Ground**

(i) Progress with tunnel / mound section – Three quotes are being sought. One already received. Same details to be sent to 2 other suppliers. Once have 3

quotes, D List to contact 3 Villages Gala for £1k funding. L Smith confirmed by the end of the meeting that the £1k from the Lottery grant can also be spent on the mound and slide instead of the stilts originally applied for, as it was "in the same spirit, with the same beneficiaries". L Smith to chase Lesley Greaves for £1,200 from donations to the Friends of RR for house sales over the summer.

AM20/186 Allotments

- (i) Garden Holders' Association update. Seed catalogues have been distributed. Revenue raised will be used to pay for a skip next year. A Facebook page has been created, which has generated lots of conversations amongst its members. Nottinghamshire Hospice has been contacted regarding their idea for overproduction of any fruit and vegetables to be donated for sale. They will be contacted again in the spring by the GHA to advise of any spare produce. Severn Trent Water have been contacted regarding delivery of compost and manure before Christmas. J Savage was thanked for providing updates on GHA member details. Regarding adjacent plots, two people have requested them if they become available and will be contacted by J Savage. Future considerations for tenancy agreements system for relinquishing half a plot if whole one is too big and clarification on joint tenancies.
- (ii) Waiting list update 8 residents and 13 non-residents.
- (iii) Maintenance and inspection update. A follow-up inspection has taken place on 13 plots, resulting in 6 being relinquished and 7 being given an extension due to difficulties arising from Covid restrictions and disruption. These will be reinspected in February 2021. Headlands have been strimmed and more work on tidying up and installing posts will be carried out over the coming months.
- (iv) Request for installation of 8ft x 10 ft shed on plot 11A. J Sherrin to ascertain use of the shed due to its large size. Approval to be delegated to Cllrs Hyde and Orders subject to response.
- (v) Access to 'Farm Road' gates restricted by STW for pedestrian safety during crop harvest noted.
