21/1949	Apologies for absence –Cllrs Y Greenfield (Isolating) J Richardson (Emergency call out) and R Ringham (Isolating)

 Cllr Ringham provide a written statement as follows: "Since the last PC meeting further discussions have taken place with our Borough and County Councillors. This meeting has strengthened further the resolve to work together better and each has a clearer understanding of how we can collectively improve Burton Joyce for the benefit of its residents. Discussions will be ongoing and will include major projects that are shared goals. It was also agreed that Sam would attend the Communities Committees on a regular basis".

- Borough Councillor's report Cllr Smith provided an update. The wooden lamp post poppies made last year are up, with donations being made to the Royal British Legion. New road signs are on order for Nottingham Road and Glen Road/Foxhill Road. GBC Parks & Street Care team have been asked to prioritise leaf clearing in the village to prevent blocked gullies. Chancellor announced 50% reduction in Business Rates for leisure facilities. Cllr Smith exploring whether the Poplars may fall under this category. Meeting with Environment Agency to be set up with Parish Council regarding Flood Warden Group insurance and responsibilities. Raffle prizes have been donated to the primary school for their Christmas Fair. Cllr Smith agreed with and supported the statement made by Cllr Ringham; that the shared liaison meetings which have been taking place with the Parish Council to date have been very fruitful.

(iv) Poplars Sports Ground Committee: Minutes of meeting held on 1st November 2021 received and noted. Open day at the Poplars to be explored. Planning application has been sent to GBC for the Causal Play area.

Proposed and resolved unanimously to donate £50 to 'Movember' for use of 3G pitch for charity match.

Proposed and resolved unanimously for the Parish Council to be formally represented at the BJ Rail Action Group

Proposed and resolved unanimously to donate and additional £50 to the Friends of Lowdham and Burton Joyce Stations for further materials for "Routes of Remembrance" poppy making. Thanks were extended to Trent Valley Councillors Smith and Adams for their contribution from the Communities Fund to further enhance the village Christmas Lights display.
