 Previous objections still stand increase water run-off from Bridle Road and
 increase in traffic & concerns regarding parking. The original front block plan
 shows the building set back from the road to allow parking for 4 cars. The revised
 plan now shows the building moved forward towards the road by approximately 3
 metres presumably to accommodate the larger floor area of the bungalows. As
 the building will be 3 storeys it will be overbearing when observed from the road,
 and will almost certainly create major car parking problems for the staff working
 in the 2 offices on a road which already has major parking problems.
