Minutes from previous meetings

i) June 14th 2022 – unanimously approved as a true record and duly signed by the Chair.

ii) Matters arising (not covered by the agenda – for information only) - None

Opportunity for questions from members of the public (15 minutes) Members of the public present sought to clarify who owns the recently fenced and gated car park at the Lee Road / Criftin Road, emphasising its importance as a community facility. Confirmed that the Parish Council are not the owners of this land and are actively exploring its ownership status. It was further noted by a member of the public that Network Rail requires unobstructed access over this land and there are TPOs on some of the adjacent trees. One member of the public noted that there is a caution on the title for access placed by an adjacent land-owner and that the other adjacent site is currently in probate. A member of the public asked who installed the fence. Cllr Fife requested that a statement be read out, previously supplied by Cllr Yates indicating that it was he who had erected the gate and fence stating the reasons for his actions. One member of the public proposed an Anti-Social Behaviour order be placed for this action. Another member of the public noted she considered the gate and fence could protect the car park. The fence and boundary lines of the installed gates and fence were discussed, and lines of access disputed. Clarified that any notices installed on the gates had not been authorised or produced by the Parish Council. Reiterated by the Parish Council that legal advice was required to interpret all concerns raised with the view of retaining and maximising the amenity and this was to be

addressed in item 22/2066b of this agenda.

County Councillor's report — Cllr Adams had given his apologies. Cllr Smith provided an update on his behalf. Cllrs Smith and Adams continue to join the 'coffee and chit chat' sessions and supported the BJ Live charity concerts in the village and the 'Run with Rich' charity event. A road speed operation is due to take place on 28th July with the road safety volunteers. Liaison with Cadent regarding the newly laid road surface being dug up for gas works have continued and there is now an agreement that it will be fully reinstated. They are also trying to bring the second phase of the works forward. A new speed sigh is due to be installed on the A612 along with a "Its 30 for a reason" sign. A review is underway for the St Helen's Grove bus stop location following repeated damage. Flood training is underway.

Borough Councillor's report – Cllrs Smith noted that numerous concerns regarding the installation of the fence and gate on the Lee Road car park have been highlighted through casework, with particularly concerns that it would lead to 'Adverse Possession' of the land and consequent loss of the village amenity of the car park. Noted that the planning application for 2 Lee Road has expired and that there are currently no live planning applications for this site at GBC.

Cllrs Smith reported that Village Centre Development plans are with VIA and Cllr Adams should have some initial design ideas following his meeting with them this week
