CE24/665 To approve the minutes of the previous meeting – Held on Tuesday 5th December 2023 approved as a true record and signed by the Chair.

CE24/666 Events programme:

- iv. **Pop-Up Food Fayre 28 January 2024** J Jephson update: Excellent feedback received from the October & January markets. Great use of OSB outdoor space with this new venture creating an event to look forward to. At present, The Popup market may be held on the last Sunday of each month from 11:00am to 16:00pm in the outdoor area of the Old School Building. With the next event on Sunday 25th February 2024. Easter Sunday 31st March confirmed. Waiting list for stalls held by J Jephson. Involve charity for Easter event of MacMillan with donations direct to this charity. Parents of Rainbows offered to volunteer with Easter egg hunt.

The Parish Council appreciate the coordination for the Pop-up events by Jane and Emily Jepson and in her suggestion of bringing the Food Fayre to the grounds of the Old School Building. Excellent events and thank you to both.

CE24/667 Village Emergency Plan:

- i. It was unanimously agreed by all for Cllr Richard Fife to co-ordinate how Burton Joyce will respond to an event/s which affect large numbers of people or the environment. Cllr Smith had also suggested (via telephone call) guidance on the plan could be sourced from both GBC and NCC.
- ii. Flood review Cllr S Smith is in process of arranging a multi-agency meeting. Yet the be confirmed by Cllr Smith a potential date of April 3rd 5-7pm.
