CE21/334 Apologies for absence – Cllrs T Hazard and L King

CE21/335 Declaration of Councillors' interests for items on the agenda - None

CE21/336 Minutes of the meeting held on July 13th 2021 – Approved as a true record and

signed by the Chair

CE21/337 Picnic

Picnic in the Park – Saturday 25th September – Agreed to change start time to 2pm for band members to have time to travel. Noted by J Sherrin that 1pm has been published in The Magazine (due for circulation from 22nd September). To advertise on Facebook, Web and Noticeboard that it will now be 2pm. Need for portaloos discussed. Agreed to request donation for a portaloo from NCC, as in previous years. J Savage to action. D List to take tables and 20 chairs to The Grove prior to the event. 5 raffle prizes to be provided each by the Parish Council and the Brass Band, totalling 10. BJ Brass to organise slotted collection buckets for both raffle ticket payments and donations. Cllrs J Johnson and J Richardson to represent Parish Council at the event.

Climate Change Group — J Devonport reported that 'No Mow May' was successful on the grass verge, with 17 species of plant identified. To repeat next year and advertise more widely. J Devonport to research and identify bird and bat box placement in The Grove. J Sherrin to chase Cadent regarding Millennium Sundial area improvements. Noted new plaques for the millennium sundial have been ordered following donation from villager. J Devonport has been liaising with ClIr S Smith regarding GBC's Draft Climate Change Action Plan and noted a dedicated Climate Officer has been employed there, awaiting finalised draft. J Jackson from Severn Trent Water will be giving a talk to the Climate Change Group regarding renewable energy — max audience 24. Ecology survey being carried out by Balfour Beatty as part of their Social Values project with the Parish Council. J Sherrin to advise J Devonport of outcome. Impact tool review — working group to look at with J Devonport to identify ways the Parish Council can influence change. Parish Council's Environment Plan to be published on the Website, along with links to the impact tool.



CE21/339 Christmas Light Switch On – Agreed unanimously that it should take place this year, providing Covid restrictions allow. Proposed date – Saturday 4th December. J Sherrin to book road closure. J Sherrin and D List carry out Risk Assessments. J Savage to organise stalls and entertainment (each providing their own Covid Risk Assessments) and for road sweep to be carried out by GBC before the event.

- **CE21/347** Liaison with Burton Joyce Primary School Primary school making application to Old School Trust for play equipment
- Village Society R Fife provided update. Growth of the new trees planted along riverside are of concern, so following up with Trent Rivers Trust. Concerns over the Co-op's internal noticeboard being retained after refurbishment is complete have been raised with Co-op management. Worked with Parish Council on village centre development and use of land beside Old School Building continues. Campaigning to retain local level crossings on the train line, with improved safety on-going. AGM will be on 22nd October in the Village Hall at 8:30pm, preceded by



a public meeting at 7:30pm on the subject of 'Burton Joyce Rail Services, Past, Present- and Future?' Sponsorship from Johnson & Partners has been received for a large, metal, lockable noticeboard for the Village Society. Permission was granted (approx. 2 years previously) for a small wooden one to be located by the old classroom at the Old School Building. R Fife to re-submit request to F&GP Committee, with details of the size and type of noticeboard, in view of the fact that this area is due to be reconfigured.
