- CE22/465** **Apologies for absence** - Cllr J Richardson (unwell), Julia Smith (unavailable to attend)
- CE22/466** **Declaration of Councillors' interests for items on the agenda** - None
- CE22/467** **To approve the minutes of the previous meeting** - 26th July 2022 approved as a true record and signed by the Chair.
- CE22/468** **Picnic in the Park** - Confirmed rescheduled of date of Saturday 1st October 2022 2-4pm

EMR - ongoing issues to be discussed at next meeting with Chris Helmore in attendance. Cllr Sam Smith will also be proving an input.
Rail crossings - continued concerns of noticeable incidents and behaviours on the crossings. A public meeting to be held at the Nelson Pub on 15th October from 10:00am until 1pm. The

event will show behaviours and video, with a view to educating the public. The EMR representative will be inviting groups across the community. Investment opinions in additional facilities including bridges, carparks, signage on gates and closures to will be wide ranging.
