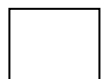
23/2119 **Minutes from previous meetings**

- i) Minutes of Annual Meeting of the Parish Council, May 16th 2023 unanimously approved and duly signed as a true record by the Chair

23/2120 **Opportunity for questions from members of the public (15 minutes)** – No members of the public present

23/2121 **County Councillor's report** – Cllr Adams reported (via Zoom). Consultation for new crossing at Mill Field Close launched this week. First part of installation process. Anticipated October start, providing Cadent Gas works stay on target. Work on the Crock Dumble due to start this summer. Enforcement of double yellow lines has started at weekends. Problem with ice-cream van running its engine by playground raised as a concern by Cllr Hadjigeorgiou. Cllr Smith to liaise with GBC's new climate officer to see if any action can be taken. Cllr Adams enquired about the zip wire and spinner currently out of commission in the playground. Cllr Hadjigeorgiou reported that she is due to speak to the installers of the spinner with the Grounds & Amenities Manager as, despite the spinner unit being replaced, the broken bearing was not. The zip slide has been recommended for a new cable wire in recent playground inspection. Launch of re-vamped library due to take place on Saturday 8th July. No report available yet on 'walk-about' for parking problems.

23/2122 **Borough Councillor's report** – Cllr Smith reported that he is aware of the Doggy Day Care application for the old Methodist Church, particularly the concerns of parking and there being no outdoor space. Recommended any comments are logged individually. The application would normally go to delegation panel, but with sufficient objections will go to committee. Joint meeting with the Parish Council and Train Action Group (TAG) regarding train timetabling was very productive. Paper being written by TAG – Burton Joyce now has a place on the board's agenda, which is a big step forward. Increasing bus fares and additional housing part of case being put to the board for more trains. A request has been made to the Department of Housing by Tom Randall MP for an amendment to the planning framework to ensure drainage systems are installed by developers prior to construction of housing to prevent flood issues. A positive response had been received by the Minister. Gedling Borough Council are also being asked to adopt a supplementary planning document. Antisocial speeding and noise also being tackled. £110 on the spot fines can now be issued via a public protection order. Cllr Smith has been approached by the Climate Action Group regarding wildflowering the grass verges. Supporting the approach and will fund the seeding. Clerk to provide information regarding BJPC



responsibilities for verge to Cllr Smith. Cllr Hazard enquired about Bulcote Farm housing development. Noted it was in Newark and Sherwood DC jurisdiction. Plans should be available on their website. Deputy Clerk to ask farms manager if the farm road will be used.
